1. Take 59 South bound towards downtown
2. Exit Downtown Destinations/Jackson Street
3. Turn Right on Franklin Street
4. Turn Left onto La Branch
5. The Toyota Center main entrance is at La Branch and Polk Street

From the North via Interstate 45:

1. Take I-45 South bound towards downtown
2. Exit McKinney
3. Turn Left onto McKinney
4. Turn Right onto La Branch
5. The Toyota Center main entrance is at La Branch and Polk Street

From the South via State Route 59:

1. Take 59 North bound towards downtown
2. Take the Polk Street/Downtown exit

PERFORMANCE RULES & GUIDELINES

As with all performances, remember the following:

1. Check In will NOT begin until the specified time on the permission slip or later; Never Earlier.
2. Prior to check in, please make sure you have used the restroom, as some performances do not begin for 1-2 hours after check in and restrooms are not always available.
3. Arrive in FULL uniform or You WILL NOT be able to perform.
4. Officers must wear their bars to be considered an officer, which means that if they forget to wear them, they are out of FULL Uniform and Rule #3 will apply.
5. There is absolutely NO Eating or Drinking in any of the Starlette Uniform(s).
6. Always wear your Performance T-Shirt as a cover up when you are not performing.
7. You must stay at least through the majority of the performance and remain in full uniform. Once we have performed and you are released to your parent/s, your director is no longer responsible for you. If you plan on staying for the remainder of the event, you **MUST COMPLETELY** change out of your Starlette Uniform, into your own clothing.
8. Directors / Officers will not have extra items of the uniform ready for you incase you forget something. It is **YOUR** responsibility to be in Full Uniform upon arrival/check in.
9. No Cell Phones, MP3 Players, iPods, Etc. Items will be taken and returned to your parents upon check out. Demerits will apply.
10. Respect all Directors, Co-Directors, Parents & Starlettes at all time.
11. No Fighting, Drugs, Weapons, Foul Language or Wondering Off.
12. Please remember that demerits will apply for any violations to the Green Starlette Rules at any time you are signed in with the Green Starlettes.
13. Absolutely no exceptions will be made for anyone. Please make sure that you are in full compliance with the rules because it is not a pleasant experience to pay for events and then have to sit-out the performance.
14. If you violate any of the above rules, your parents will be called and you will be asked to leave the event.

If I am signing this waiver and release on behalf of my child or ward, I represent that he or she is in physically sound condition, has no disability, illness or other condition preventing him or her from engaging or otherwise participating in any basketball-related activity, other non-strenuous athletic activity or contest, or any other promotional activity including without limitation, dancing, singing or other exhibition.

I hereby understand and acknowledge that participation in the aforementioned activities involves certain inherent risks and that regardless of the precautions taken by Harlem Globetrotters, Campbell's, Howard Johnson, NVI, Greyhound or the participants, some injuries may occur. These injuries include but are not limited to: bruises, sprains, strained muscles, broken bones, overexertion, dislocated joints or ligament injuries.
